SECTION E CERTIFICATION

This certification is to be signed by a land surveyor, engineer, or architect who is authorized by state or local law to certify elevation information when the elevation information for Zones A1-A30, AE, AH, A (with BFE), V1-V30, VE, and V (with BFE) is required. Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.

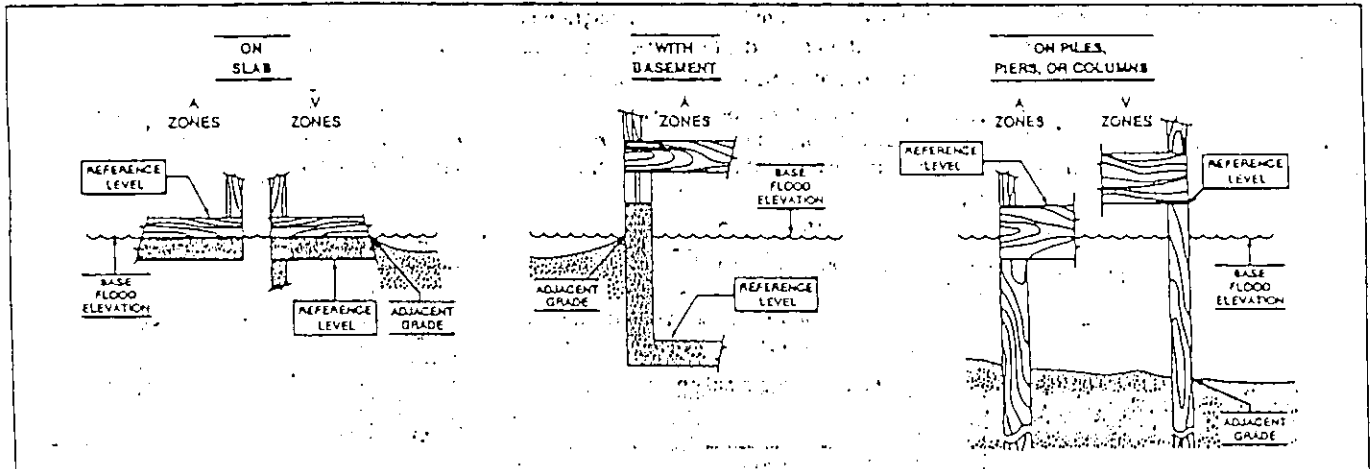

COMMENTS: 1 story CBS dwelling on concrete columns with ground level enclosure of greater than 300 Sq. Ft. area enclosed by solid walls. Elevation of first elevated floor = 16.9 Ft. Elevations are expressed in feet referenced to National Geodetic Vertical Datum, 1929 Adjustment and are derived from direct, closed level circuit from NGS Benchmarks G-27B and F-27B, both published January, 1972.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
