- 1. The meeting was called to order at 7:00 p.m.
- 2. Mayor Halle led the Pledge of Allegiance
- 3. Vice Mayor Lewis led the invocation.

- Councilwoman Cindy Lewis motioned to approve tonight's agenda. The motion received a second and approved without objection.
- 6. Vice mayor Greg Lewis motioned to approved previous meeting minutes. The motion received a second, and minutes were approved unanimously with no objections.
- 7. Mayor, Committee and Staff Reports
 - A. Mayor Bruce Halle

- permitting. His objective is to widen both sides and make navigation easier. Mayor Halle's boat ramp will be closed during this time. An email will be sent via Constant Contact to inform Layton's citizens.
- 3. Mayor Halle Introduced Steve DeArruda, Tracy Froitzheim and Jared Rodriguez who are interested in filling Seat One by appointment at tonight's meeting. The appointee shall only serve the remainder of the term. Seat 1, is up for election in November. Mayor Halle asked if city council members had reviewed the questionnaire and bios that was sent to the council last week. All council members acknowledged that they had. Mayor Halle asked it the council had any questions, none were made. Mayor Halle stressed the importance of attending city council meetings in person especially being present physically at the Budget hearings held in September to ensure a full quorum is present.
 - * Steve DeArruda attended via zoom. He thanked everyone for the opportunity to serve his hometown * Tracy Froitzheim was unable to attend in person. She was having technical difficulties but spoke to the council and gallery via telephone call in. She stated that she would love the opportunity to serve and
 - * Jared Rodriguez attended the meeting in person. He stated that he is very excited for the possibility of serving and attendance would not be an issue.

- B. Vice Mayor Greg Lewis has been working on repainting the speed bumps on South Layton Dr. He will continue on Tuesday if weather permits. Mayor Halle and Councilman Greg Lewis are part of the FL Keys Transportation committee. A Keys project review of a five-year master list is in the process of being finalized. The 18- mile stretch is expected to be fully repaved by October 2025. The Long Key Bridge repair is expected to be completed in July. Work will be conducted at the airport in Marathon. There are currently no projects in the City of Layton scheduled. Mayor Halle commented that traffic congestion is heavy in the Keys currently and would probably continue for some time.

 C. City Clerk Mimi Young will present the financial report after the March numbers are determined.
- D. City Attorney- Hunter O'Conner had no report but explained the next action item's procedures. City attorney Hunter O'Connor explained that any council member can motion to appoint one of the nominees, if the motion gets a second, roll call would be taken, city council members could either say yes, no, or nothing at all (which would count as a no vote). He explained that if the first nominee didn't receive

enough votes to be appointed, another council member could motion to approve their choice, and if it received a second, another roll call would be taken. This process would continue until an appointee was agreed upon. However, he stated if the first nominee received enough votes, then the nominee would be appointed, and the process would end. He asked everyone present if they understood the process and received affirmation that they did. He also asked if anyone had any questions and none were made.

8. New Business: Consider and approve the new Appointee to fill Seat 1, the candidates are Steve DeArruda, Tracy Froitzheim, and Jared Rodriguez. Mayor Halle asked for a motion. Vice Mayor Greg Lewis motioned to appoint Jared Rodriguez, Cindy Lewis made the second motion, roll call was taken.

*Cindy Lewis responded that it was very nice to see so much involvement and interest. All interested candidates had strong qualities that our city needs.

*Councilwoman Susan Grant thanked everyone for attending. She reiterated that it was insightful to have 3 candidates interested in running for the council.
